Ray Gregg presented the Treasury Report: the Chapter balance is \$2,769.68.

The Chapter will be selling water & soft drinks on Saturday and Sunday, March 26 & 27, during Mike Bruno's Bayou Thunder weekend. We still need some volunteers for this assignment. Besides helping the Chapter's piggy bank, it is a good excuse to have some fun hanging around, grooving on the music and checking out all the bikes. Walton and Johnston will lead a ride.

A trip to Key West, Florida is scheduled for April 17. The Group (consisting of Chapter Officers who attended the HOG sponsored training session in Jacksonville) will depart Jacksonville en route Key West, spend a couple days in the Keys and return to Slidell via the west coast of Florida. For particulars regarding the point of departure, contact Dwight Bradbury if you would like to join them.

Ladies of Harley will have an overnight ride to Bellingrath Gardens in Alabama, with a departure date of Saturday, June 25. Details of this trip will be forthcoming.

Mike Bruno's has a \$300 gift certificate program. Drawings are held monthly. Details will be announced.

Although not a H.O.G. event, Russ Davis briefed the Chapter about an upcoming A.B.A.T.E. Poker Run for charity scheduled for Saturday, May 21.

There being no other business, the meeting was adjourned to give everyone time to do a Group Ride to Tony's Po-Boy Restaurant in Chalmette.

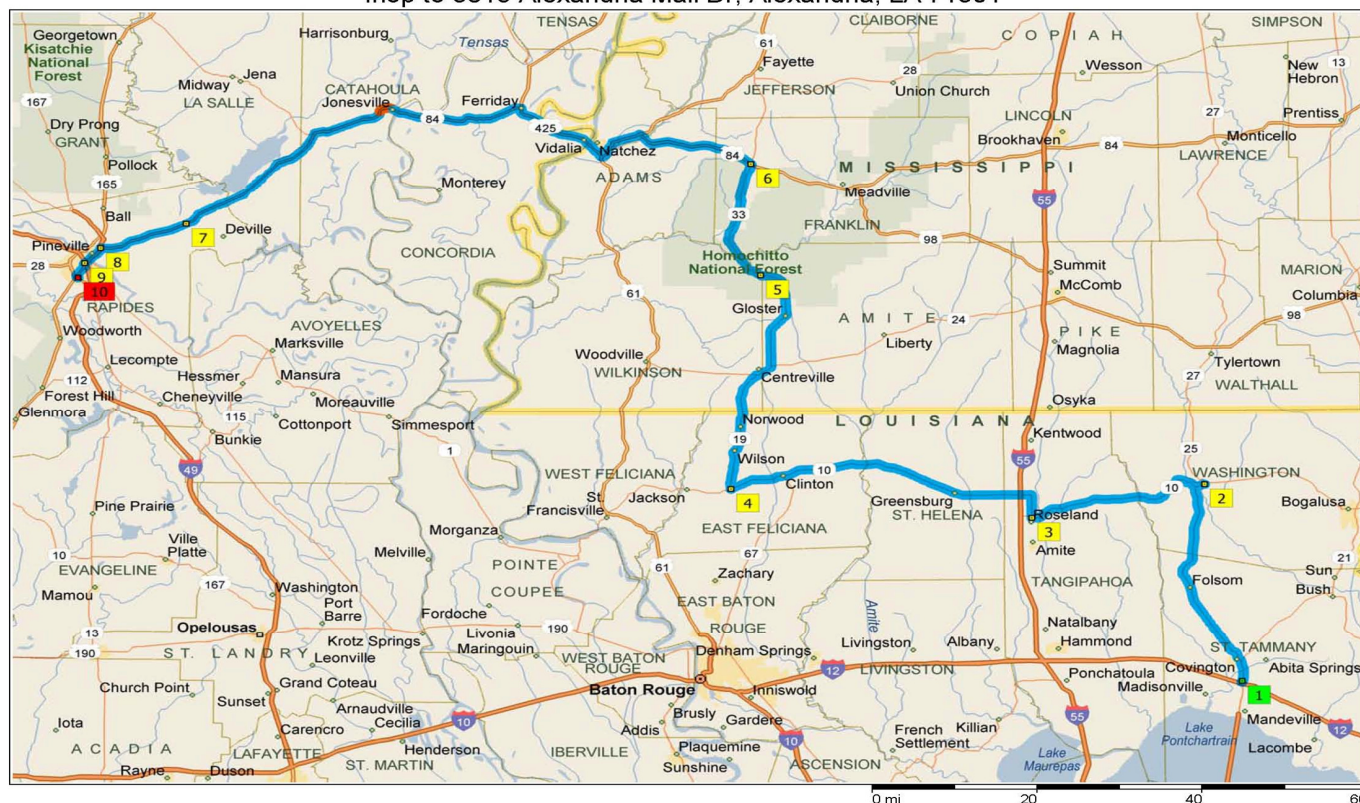
