#### October 18, 2003

#### November 15, 2003

- 1. The meeting started with the Pledge of Allegiance.
- New Members were introduced and welcomed to the chapter. (See page 3 for a list of new members who have joined the chapter over the past couple of months.
- 3. The Treasurer, Joe Toranto, discussed plans for the Christmas Party to be held on December 5th at the Bon Fouca Banquet Room. Starting time is 8:00 PM and will go to midnight. This year, at the request of many members who attended last year, the bar will feature premium alcohol drinks at a slight increase of only \$4.00 per member. Nonmembers must pay an additional \$8.00. Additionally, Joe presented the monthly Treasure's Report (see below).
- 4. Jerry Norman discussed the chapter trip to the Natchez Balloon Festival and the State Rally in Shreveport for 2004. As more information becomes available, we will announce plans to go to Shreveport as a chapter.
- 5. The election of officers was delayed until the December meeting on the 20th of the month. Langston Walker will offer a 10% discount for all officers on parts, accessories and clothing as a reward for becoming an officer in the chapter.

- 6. Jerry Norman offered the safety tip for the month regarding tire pressure for the upcoming winter months. In short, as the temperature decreases, so will the air pressure in your tires so check them on a regular basis. He also recommended not using "Fix-It Flat" because the use could cause a blowout.
- 7. For those of you who signed up for the advanced rider's course, Langston and Jerry said that they would work on getting the instruction and riding course restarted.
- 8. Langston talked about next year's events such as Bayou Thunder and the HOG Roast. Again, more information will be forthcoming as those events draw nearer.
- 9. In the past, we used to call members on a monthly basis to remind them of such things as the monthly chapter meeting, changes to planned events, upcoming activities, et cetera. To do so, required not only volunteers to do the calling, but a lot of an individual's time. Ladies of Harley officer, Donna Graffagnino, had a group of lady volunteers to do the calling, but that has waned over time. Nevertheless, this particular way of providing information to members proved to be the best way of keeping everyone up-to-date. For that reason, Langston said that he was looking into a telephone calling service that we could enlist to keep everyone informed about chapter activities.
- 10. The meeting ended with about twelve riders and their passengers taking part in the optional Saturday ride which went along the Mississippi coast to Ocean Springs.
- 11. The next meeting is scheduled for Saturday, 9:00 AM, December 20, 2003.

#### **SAFETY PIN CORNER**

#### **Winter Reminders:**

We've been pretty fortunate this fall with the good weather we have had for riding. However, it probably won't last much longer. So, expecting the worst, think about a few things as the weather turns more "wintery."

- 1. Ain't nothing like a good set of warm gloves. Ever tried to work those controls with a frozen pair of paws? Not too easy is it? A hint to keep those digits toasty is to purchase a set of latex rubber gloves (anyone male over 50 knows who uses these!) to go inside of your regular gloves. Great insulation and certainly a more comfortable to use than how the doctor uses them.
- 2. Hey, what about those toes? A cheap, but effective, way to keep those particular digits warm is to not only get a couple pair of warm woolies but also use the type of plastic bags you carry out your groceries with and place them over your feet before you put your boots on. Hell, who's gonna' know? The more insulation the better!
- 3. And remember to layer your outerwear. One big jacket usually does not do the trick. You're better off with some "long johns," a sweater (or two) and then that motorcycle jacket. Another trick is to simply use your rain gain gear as an extra layer of protection. Sure helps keep the wind out.

Bottom line: The warmer you are the safer you will be.




