Northshore Chapter members to become more active and add to their enjoyment of HOG events. Contact Mike if you are interested in this fun opportunity.


Dwight Bradbury, gave a brief on membership renewal requirements and his Treasurer's report. We currently have \$1820 in our Chapter account.
